The **ISI (Indian Standards Institute)** mark is a certification mark that signifies a product's adherence to Indian safety and quality standards. It is issued by the Bureau of Indian Standards (BIS), the national standards body of India. The ISI mark ensures that products meet specific Indian standards regarding performance, quality, and safety. It covers a wide range of products, including electrical appliances, cement, packaging materials, and more.





What Does the ISI Mark Do?



Assures Quality:

The ISI mark guarantees that the product meets the required specifications and is of high quality, helping consumers make informed choices.



Ensures Safety:

Products with ISI certification have passed rigorous testing for safety, minimizing the risk of malfunction or hazards.



Legal Compliance:

For certain product categories, such as electrical goods and pressure cookers, ISI certification is mandatory. Products without this certification cannot be legally sold in the Indian market.



Boosts Consumer Trust:



The ISI mark enhances consumer confidence, as it signifies that the product has been vetted for quality and safety by a trusted authority.

Step 1

- Identification of documents
- Compiling of required documents
- Submission of application
- Filling of Application



Step 3

- Preparation of Manual
- Preparation of product technical manual
- Technical specification



Step 5

- Inspections by the Department
- Inspection team will visit on the site
- Team will verify the process & quality as per standard



Step 7

- Closure of Non-Conformity (if any)
- Rectify the process if inspection team points out
- Intimate to and get verified by the department

Step 2

- Organize the Lab Test Report (LTR) by BIS
- Collecting the sample from manufacturing site
- Select the BIS recognized lab
- Provide the sample of product to get tested
- Get the test report

Step 4

- Technical Documentations
- Declaration of Conformity
- Declaration of Supportive Evidence Documentations

Step 6

- Collection of required samples and documents for BIS lab testing
- Make sure the appropriation of ISI Code filled-up form for lab testing
- Submission of test report & Request for Inspection

Step 8

- Get the ISI Marking /Registration


